Mary is proud to say it is a joyful place where the residents, whom she considers to be family, are encouraged to invite their relatives, including their grandchildren and pets, for visits. She notes that their families are welcome to swim with them in the pool, which residents use for recreation, exercise and pool therapy. Residents celebrate birthdays together with their loved ones and, at Christmastime, everyone is invited for holiday dinner at the home. After dinner each night, residents are welcome to sit in the living room and listen as Katie, who has years of classical training and enjoys performing for the family, plays the piano. "It's really whatever the residents wish to do," Mary says. "As I see it, this is their home and I am here to serve them."

Several special animal members of the family have also enhanced the atmosphere within the house over the years. Charming dogs, Moses and Abraham, welcomed guests to the home, as have two friendly parakeets.

What makes this six-bedroom, family setting so special is the respect shown for the residents, who are provided home-cooked meals, approved by a registered dietician; scheduled activities daily; home health therapy with a doctor's order; transportation to and from appointments; and, as needed, hospice, memory, respite or limited nursing care. Even more impressive is the ratio of staff to residents, which is 1 to 2.3, ensuring that each individual receives the utmost in personalized care.

Other features that make Mary's on Bayshore stand out is its consistent, dedicated staff, with a registered nurse in residency twenty-four hours a day, seven days a week. Mary says, "This kind of care allows us to observe residents and address health concerns early on, thereby avoiding admissions to an emergency department or hospitalizations."

"For the first time," Mary notes, "the area in and around Venice is saturated with assisted living options, but we are proud of our incomparable, holistic concept that nurtures

the body, mind and spirit." Substantiating its value to the community, she adds, Mary's on Bayshore was awarded the Venice Gondolier Sun 2017 Readers' Choice First Place Best of Venice Award for Small Assisted Living Facility.
